Subject: Violation of the Nuremberg Code by the Government of Israel and other parties

On behalf of the "People of Truth" Association (hereinafter referred to as "The Association") this Notice is given to the Government of Israel, including Knesset members, Ministers, senior elected officials, Mayors and other government officials. "The Association" is a group of citizens of Israel and others, including lawyers, doctors, public activists and the general public, who have chosen to exercise their democratic right to not receive the experimental medical treatment known as the Corona vaccine/Covid19. "The Association" members assert that they are being severely and illegally pressured by the Government of Israel, the Knesset members, ministers, senior elected officials, mayors and those people acting under the Government of Israel's direction. (Hereinafter collectively and independently referred to as "The Government")

Facts Upon Which "The Association" Alleges That the Actions of "The Government" Violate The Nuremberg Code

The Corona vaccine is an innovative medical treatment that has only recently received FDA Emergency Approval in the United States, which is not Final Approval. Twenty two (22) side effects of the vaccine were listed. Additionally, it is undisputed that the Corona vaccine has not been studied or clinically tested for it's long-term

vaccine effects in any scientific test (trial and research). Therefore the long-term effects of treatment and its safety for its recipients are still unknown.

- It is important to note that human vaccines have never been given worldwide using this medical technology (synthetic M-RNA insertion); all previous vaccines have worked completely differently with the introduction of a killed or attenuated virus / virus and the natural stimulation of the immune system against it.
- "The Nuremberg Code" is a code of medical ethics issued on the basis of laws under which Nazi criminals were criminally tried for horrific medical experiments conducted during World War II, at the Nuremberg Trials. The Nuremberg Code later formed the basis for the enactment of the Helsinki Declaration.

"The Association" intends to present evidence and to prove that members of "The Government" have collectively or independently, in the State of Israel, violated the Nuremberg Code in a criminal, blatant and extreme manner repeatedly during the period of time including but not limited to 2021 and 2020.

A. Requirement of Informed consent to participate in a medical trial - The first principle of the Nuremberg Code requires the voluntary and informed consent of the person to receive the treatment and to participate in the clinical trial. The person is entitled to exercise freedom of choice, without the intervention of any factor that exercises force, deception, fraud, threat, solicitation or any other type of restraint or coercion.

However, when the Minister of Health and the Prime Minister of Israel presented the vaccine in Israel, actively campaigned for persons in Israel to take the vaccine, and vaccinated the residents of Israel, the vaccinated persons were never informed by "The Government" that they were actually participating in a medical experiment and/or that their informed consent was required in accordance with the Nuremberg Code. The Israeli Prime Minister signed an Agreement with Pfizer, this Agreement is not fully publicly known, due to the redaction (blacking out) of many of its contents. Those contents which are not redacted state that the Prime Minister agreed that that a medical experiment be conducted upon the citizens and/or residents of the State of Israel. In fact, shockingly, this is the essence of the agreement. It is in fact a medical genetic experiment upon

humans that has been done without informed consent, a serious and blatant violation of the Nuremberg Code.

B. Requirement that Personal Medical Information be Kept Private: The Israeli Prime Minister signed the contract /agreement with Pfizer (the manufacturer of a Covid19 vaccine) which obligated "The Government" to transfer the personal and medical records of Israeli citizens and residents to Pfizer, and for Israeli citizens and residents to be the drug recipients in the experimental trial. In return gave Israel priority over other countries to receive a huge amount of vaccines. Israel did quickly receive 1 receive millions of vaccine doses and priority over other countries.

The Prime Minister, "The Government" agreed and that the personal and medical information which "The Government "possessed would be transferred to the Pfizer, without any requirement described in the publicly known/ un-redacted portions of the Israel/Pfizer Agreement mandating the knowledge or the prior consent of any person who is or was the subject of the medical or private data given to Pfizer.

Please note that until the present time, the full and complete content and terms of the Agreement between The Government" and Pfizer, which was signed by Prime Minister Netanyahu, is unknown, due to the redacting, or blacking out of many of the document's terms and conditions contained in its content. "The Government" has and continues to refuse to publicly reveal or publish the entire, un-redacted Pfizer/Israel Contract, despite numerous public demands to do so.

C. The Nuremberg Code's Requirement for the Informed Consent of the Tested Persons Includes the Advisement of Alternative Therapies - Informed consent for medical treatment based on the Nuremberg Code requires that the patient be informed and offered treatment alternatives. Each treatment alternative must include: details describing the medical process; details describing the advantages, disadvantages, benefits and risks of each treatment, to enable the patient to make an informed and personal decision.

It is required that the patient make the decision regarding his/her treatment without any exercise of any pressure whatsoever and of any typethe decision must be made freely, and not under any type of duress or coercion exercised upon the patient. However, in violation of this Nuremberg Code requirement, "The Government" has not presented

to the general public recognized alternatives to prevent and/or lessen the severity of the Corona disease, despite that these alternative therapies have been shown to be effective and with few and not dangerous side effects. Consequently, "The Government" has created an atmosphere of fear and coercion, pushing the public to accept the Corona vaccine and become a test subject. Again, the Nuremberg Code has been violated by "The Government."

- D. The Nuremberg Code requires that the medical experiment be conducted in a way that will prevent suffering or physical injury. It is known that the treatment caused the deaths of many persons and injuries (including disability and paralysis) after receiving the vaccine. Despite this, "The Government" did not order any investigation into the matter. It is interesting to note that the Ministry of Health has openly admitted that 41% of police, military, education and medical personnel who took the vaccine suffered from severe and/or life-threatening side effects. It is also puzzling to note that there are no complete and public official reports of the number of deaths or injuries to persons who took the experimental vaccine in the State of Israel.
- E. The Nuremberg Code mandates that the experiment should not be conducted when there is reason to believe that actual death or injury will occur. For a violation of this principle, see Item "D" above. We the public hear only by word of mouth, on social networks (by friends, neighbors or relatives), and not in the mainstream media from official government sources. Instead, "The Government" continues to tell us, plead with us, shame us into taking the experimental Corona vaccine.
- F. The Nuremberg Code requires that the person in charge of the medical experiment will stop it at any stage, if there is a reasonable basis to believe that continuing the medical experiment will lead to injury, disability or death of the participant in the experiment. It has already been proven that many vaccine recipients have died from the treatment, or were injured, became disabled and paralyzed, but the Israeli government continues to impose and promote and campaign for this dangerous experiment on Israeli citizens.

"The Association" lists the following actions of "The Government" which we assert to be violations of the Nuremberg Code (as will be attached later, in the Appendices):

Applying economic pressure:

- .1The Manufacturers' Association, backed by a legal opinion, is threatening to expel anyone who does not get vaccinated.
- .2Minister of Health Yuli Edelstein seeks to enact a law that will prevent unvaccinated people from entering the workplace.
- .3Threat of denial of unemployment benefits.

Applying social pressure:

- .1Threat of preventing entry to places of entertainment, leisure and receipt of services from the community.
- .2The solicitation of celebrities, opinion leaders (influencers), as well as elected officials, which advocate and socially pressure the public to accept the experimental vaccine. The use of these public figures and members of "The Government" to propagandize, and aggressively and offensively threaten punishment and sanctions for those persons who will not consent to the medical experiment. Examples of such persons are MK Ayelet Shaked, MK Smotritz, Health Minister Yuli Edelstein, MK Bennett, Avri Gilad, host of the morning program, singer Yehoram Gaon, Judy Nir Mozes and others.(
- .3Using vehicles with loudspeakers to travel around the Israeli cities and towns, urging residents to take the vaccination.
- .4Citizens and residents receiving repeated aggressive calls and messages from the health funds and even making appointments for the insured, without any permission or request for a vaccine appointment.
- .5Financial Incentives for vaccine experiment acceptors, prohibited for vaccine refusers:
- a. Receiving a night at the hotel, days off work and more which the owners of various companies offer to their employees.
- .2Discounts at various private and public businesses, as well as a financial benefits card promoted by the government.

The Actions of "The Government" Also Violate Israeli Law, in Addtion to the Nuremberg Code

The Prime Minister of Israel has said more than once that the citizens of Israel are participating in the above-mentioned medical experiment for the benefit of all citizens

of the world. It appears that the citizens of the world are in no hurry to receive the experimental emergency use medical treatment and their eyes are on the Israeli experiment.

The Israel-Pfizer Agreement, heavily redacted/blacked out by "The Government", raises more suspicions and questions about the conduct of "The Government", whether there are additional Nuremberg violations as well as additional violations.

It is hereby emphasized that the measures currently used by citizens, including the proposals for legislation against those who have not been vaccinated, are contrary not only to the Nuremberg Code and to the autonomy of the individual, but also to existing legislation in the country, including the Basic Law of Human Dignity and Liberty,, The Equal Employment Opportunity Law, the Prohibition of Discrimination in Products, Services and Access to Entertainment and Public Places and other Israeli laws.

Therefore, in light of the above, we demand the following of "The Government:"

- .1 Immediately cease the medical Corona vaccine experiment and the to cease the administration of vaccines to the population of Israeli citizens and residents.
- .2 Order "The Government" to stop any legislative or administrative procedure that violates the requirement of voluntary and informed consent of the person/recipient of the Corona vaccine medical treatment, including but not limited to:
- a) The issuance or recognition of a green tag or passport;
- b) Transmission of any and all private medical data, including but not limited to vaccination status or history to local authorities or other public or private businesses or organizations, or their agents;
- c) To cease and desist from enacting or approving any future legislation, action, or regulation which violates the Nuremberg Laws and/or Israeli law; to prevent by its governmental authority any public / business / employment entity that violates Israeli laws regarding employment discrimination and equal access to public and private services and/or benefits based upon Corona vaccine status.
